

A minimum score of 70% and full compliance to returnable documents will qualify a bidder for further evaluation.

#### 1.2.21 Points for Preference

A maximum of 20 (twenty) tender evaluation points will be awarded for preference to Tenderers with responsive tenders, who are eligible for such preference, in accordance with the criteria listed below.

#### 1.2.18 Exempted Micro Enterprise or B-BBEE Status Level of Contributor

#### 1.2.19 Risk Analysis

Notwithstanding compliance with regards to CSD registration or any other requirements of the tender, the employer will perform a risk analysis in respect of the following:

- (a) electronic copies of the contract document, or parts thereof, will only be provided to Tenderers who have been issued with the tender documents in hardcopy;
- (b) the electronic version shall not be regarded as a substitute for the issued tender documents:
- (c) the Employer shall not accept tenders submitted in electronic format. Tenderers may not complete and submit a printed copy of the electronic version of the tender document or part thereof. Only those tenders that have been completed on the issued hard copy tender document shall be considered;
- (d) the Employer accepts no responsibility or liability arising from any reliance on or use of the electronic version provided in terms of this clause. The Employer further does not guarantee that the electronic version corresponds with the issued tender documents in all respects. Tenderers are alerted to the fact that electronic versions of the tender documents may not reflect any notice or addenda that amend the tender document;
- (e) any non-compliance with these provisions, including effecting any unauthorized alterations to the tender document, shall render the tender invalid. The Employer reserves the right to take any action against such Tenderer allowed in law including, in circumstances where the tender had already been awarded, the right to cancel the contract.

(f) In requesting the electronic version of the tender document or parts thereof, the Tenderer is deemed to have read, understood and accepted all of the above conditions.



#### 1.2.24 Issue Addenda

#### 1.2.25 Non-disclosure

Not disclose to Tenderers, or to any other person not officially concerned with such processes, information relating to the evaluation and comparison of tender offers, the final evaluation price and recommendations for the award of a contract, until after the award of the contract to the successful Tenderer.

#### 1.2.26 Grounds for rejection and disqualification

Determine whether there has been any effort by a Tenderer to influence the processing of tender offers and instantly disqualify a Tenderer (and his tender offer) if it is established that he engaged in corrupt or fraudulent practices.

#### 1.2.27 Test for responsiveness

Determine, after opening and before detailed evaluation, whether each tender offer properly received

- a) complies with the requirements of these Conditions of Tender,
- b) has been properly and fully completed and signed, and
- c) is responsive to the other requirements of the tender documents.

A responsive tender is one that conforms to all the terms and conditions of the Tender documents without material deviation or qualification. A material deviation or qualification is one which, in the Employer's opinion, would:

- 1.2.29 Notify the Tenderer of all errors or omissions that are identified in the tender offer and either confirm the tender offer as tendered or accept the corrected total of prices.

  - a) If Bills of Quantities or Pricing Schedules apply and there is an error in the line item total resulting from the product of the unit rate and the quantity, the line item total shall govern and the rate shall be corrected. Where there is an obviously gross misplacement of the decimal point in the unit rate, the line item total as quoted shall govern, and the unit rate shall be corrected.

## 2. SCOPE OF WORK

Legal practitioners as defined in the Legal Practice Act, 2014 (Act No. 28 of 2014), and who are employed by CoGHSTA for the purpose of providing a dedicated source of legal services and advice in exchange for remunerations must comply with all the provisions of the Act and must adhere to the provisions of Part VII of the Code of Conduct for all Legal Practitioners, Candidate Legal Practitioners and Justice Entities (GN 168 of 29 March 2019 as published in Government Gazette No. 42337 (as amended) and read together with its Regulations.

The successful tenderers will be required to adhere to the principles and conditions of legislation and policies/frameworks applicable to the relevant category of work tendered for.

## 2.1. Categories of services required

CoGHSTA would require legal services in the following categories:

## 2.2. The requirements pertaining to the legal services to be rendered will include, but are not limited to the following:

The successful tenderers must -

- 2.2.1. Be able to provide general legal services in respect of the various categories of service tendered for to organs of state.
- 2.2.2. Be able to conduct detailed and credible research in identifying and applying the applicable laws and regulatory framework to the given set of facts in appropriate cases and providing solutions thereto.
- 2.2.3. Must provide legal opinions in the various categories of service with a specific focus on the applicable laws and regulatory framework.
- 2.2.4. Provide broad investigative and related legal support to the CoGHSTA in respect of the matters in the various categories of service tendered for.
- 2.2.5. Assist the CoGHSTA in its interaction, and liaison with as well as the management of stakeholders, if and when required.
- 2.2.6. Have an understanding of the legislation and the regulatory framework and requirements applicable to provincial governments in respect of the various categories of service tendered for.
- 2.2.7. Provide legal interpretation as well as independent and impartial legal advice to the CoGHSTA in respect of matters relating to the specific category tendered for.
- 2.2.8. Represent CoGHSTA in legal and litigation matters pertaining to the various categories of service tendered for, including services related to Magistrate and High Court litigation, as well as other dispute resolution mechanisms, as and when required.
- 2.2.9. Facilitate engagements between the CoGHSTA and other parties.



2.2.10. Represent CoGHSTA in Mediation and Arbitration and other dispute resolution forums.

## 2.3. The following special conditions and service standards will apply:

- 2.3.1. For every assignment CoGHSTA will provide particulars to the successful tenderer.
- 2.3.2. Successful tenderers are not guaranteed any work under this tender proposal and the acceptance of the bid and the appointment of a tenderer to render specialized and advisory services pertaining to matters in the various categories of service depend on whether a need arises. It should not be construed as assurance that any amount of work will be awarded to the tenderer during the contract term.
- 2.3.3. CoGHSTA may by mutual agreement amend the particulars of an assignment to the extent that it will not significantly influence the original request.
- 2.3.4. CoGHSTA reserves the right to consult/interview successful tenderers prior to the commencement of an assignment.
- 2.3.5. The successful tenderers, by representing CoGHSTA, will be required to adhere to the principles and conditions of legislation and policies/frameworks applicable to the various categories of service tendered for.
- 2.3.6. The successful tenderer must conduct its business during the business hours of CoGHSTA and must be readily accessible to the Department's staff. In the event of emergencies, after-hours work may be required in which case the tendered rates will apply.
- 2.3.7. The successful tenderer must be conversant with, conforms to, and complies with all statutory provisions, regulations, and by-laws relating to its business provided in terms of the required services.
- 2.3.8. The successful tenderer must perform all duties with due regard to the provisions of the Occupational Health and Safety Act, 1993 (Act No. 85 of 1993) and the Regulations promulgated in terms of the Act and adhere to all safety rules and regulations.
- 2.3.9. CoGHSTA reserves the right not to issue any assignment to a candidate attorney, although they may perform legal work under the supervision of their own principals.
- 2.3.10. It will be expected of successful tenderers to always protect CoGHSTA's interest in all legal matters
- 2.3.11. The basis of engaging the successful tenderers will be on an assignment (if and when required) basis.
- 2.3.12. The successful tenderers must supply their own resources in respect of offices, personnel, vehicles, and equipment required.
- 2.3.13. Successful tenderers shall not settle or compromise any claim or initiate litigation on behalf of CoGHSTA, without the necessary consultation and approval of CoGHSTA.
